TERMS | CONDITIONS



Introduction

The Terms and Conditions (TC) are applicable to a contract closed between the APPAREL SOURCING CLUB (hereafter 'the CLUB') as represented by '4You Modevertrieb GmbH' and the natural or legal person joining the CLUB as member.

CLUB-MEMBERSHIP: The CLUB present manufacturers of apparel products including accessories. The application can be submitted by completing and submitting the application form to info@sourcingclub.net or by registering online on www.sourcingclub.net. The Application will be validated by the CLUB who would admit the applicant to join the CLUB. The notification of the admission will need to be confirmed by the member in writing by email, subsequently entering into a contractual relationship with the CLUB. There is no automatic entitlement of membership or participation in the DAY event upon submission of the Application.

The participating member agrees that the CLUB receives, processes and publishes the information received from the Manufacturer at its own discretion, for the purpose of making available the company profile to e.g. interested clients, media, other stakeholders.

Regular Membership

Membership is for one year as of the date the payment has been received. The CLUB will inform all buyers about the new member with a profile description also to be published on the online CLUB-database. The CLUB will connect the Manufacturer with Sourcers on an on-going basis throughout the year (based on requests reaching the CLUB from Sourcers).

DAY-Participation

DAY-PARTICIPATION: The DAY event is the annual physical presentation of Member Manufacturers. The physical presentation space will consist of: 1 standard table capable of hosting four chairs, 4 chairs, 1 clothes hanging rail with a hanging capacity of at least 100cm, 10 hangers made of wood or plastic, 1 table sign with the logo and the name of the exhibitor. The booth location and design rests solely with the CLUB. The member will receive the location within the venue at least seven calendar days prior to the event. The member participating in the DAY event is responsible for providing the CLUB with all the necessary information to complete the online manufacturer profile. The participating member is not permitted to sub-let the presentation space to another company without the written approval of the CLUB. The participating member will follow the guidelines of the CLUB concerning the presentation of products. No extra marketing or advertising material such as posters or other visual and audio carriers are permitted. Participating members will need to be fully available with a readily fitted presentation station as of 09h30 on the day of the event. The exhibition venue will be accessible as of 07h30 on the day of the event for the exhibitors to equip their presentation station. There will be a separate room available to store empty containers such as suitcases for the day. Members will need to remove all presentation items after the event any by no later than 18h30 on the day of the event. Any items left will be removed and destroyed at the expense of the exhibitors.

Prices / Payment Terms

The Membership fee is EUR 400,00 per year, covering the [CLUB-services](#). The fee for participation in the DAY is EUR 1.750,00 including the annual membership (CLUB-members thus pay EUR 1.350,00 for the DAY participation). Existing Members will need to inform the CLUB in writing that a participation in the DAY is envisaged. Should the DAY event take place during a valid membership period, the participation fee will be calculated by deducting EUR 33,33 per month of valid membership, renewing the membership for a duration of twelve months as of the DAY event.

The member will pay the fee in full in the EURO currency to the account of the organiser. Banking charges are fully paid by the member:

Participating members from non-EU countries are required to provide the CLUB with a current excerpt of the company incorporation document from e.g. the local administration or Chamber (not older than one year), enabling the CLUB to issue an invoice without German VAT. If such as document is not produced, a VAT rate of 19% will be charged to the invoice. Members located in the EU need to provide the CLUB with a valid VAT number to receive an invoice without VAT.

Termination / Cancellation Policy

No cancellation and no refund applies to the CLUB membership for the duration paid for by the member. Membership is not automatically extended and needs to be renewed following the period of twelve months when the member should inform the CLUB in writing that its membership is to be continued for a period of 12 months.

The following refund policy applies to the participation in the DAY event, subject to the CLUB receiving and confirming the pro-rata cancellation (DAY participation fee only) in writing by email (info@sourcingclub.net), covering the DAY participation:

- 50% refund if cancelled and confirmed 60 calendar days prior to the event
- 25% refund if cancelled and confirmed 40 calendar days prior to the event
- 0% refund if cancelled after the 40th calendar day prior to the event.

The CLUB will try to re-sell the space and shall notify the exhibitor if done so successfully. In this case, 85% of the fee will be reimbursed, keeping a 15% administration fee for the CLUB. A now-show of the exhibitors qualifies for the full payment of the fees, no reimbursement applies.

The CLUB reserves the right to cancel the DAY event up to 20 calendar days prior to the planned date without stating reasons. In this case, the participation fees already paid will be reimbursed in full but without the membership fee. If the DAY event is cancelled due to Force Majeure (e.g. pandemic), a full refund of the fees already paid applies.

Other provisions

By signing the registration form, the participating member accepts these terms and conditions of as well as all further regulations concerning the contractual relationship, as binding.
